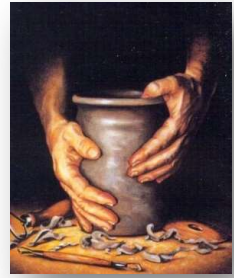


# Ministerial Credentials Board 2020
